Sr Anna Stiegler OP (aged 60, German citizen, **shot dead** by guerrillas)

Sr Berta Schneider OP (aged 73, German citizen, **shot dead** by guerrillas)

Sr Christa Elisabeth Lewandowski OP (aged 43, German citizen, **shot dead** by guerrillas)

Fr Christopher Shepherd-Smith SJ (aged 34, British citizen, **shot dead** by guerrillas, was present at the mission only because his motorcycle battery had died)

Fr Dunstan Myerscough SJ (aged 65, British citizen, shot by guerrillas, survived)

Br John Conway SJ (aged 31, Irish citizen, **shot dead** by guerrillas)

Fr Martin Thomas SJ (aged 44, British citizen, **shot dead** by guerrillas)

Sr Pauline Wilkinson OP (aged 59, British citizen, **shot dead** by guerrillas)

Church leaders are subjected to a ‘trial’ at a public rally led by President Idi Amin on fabricated charged of arms smuggling where they were forced to stand for hours in the sun with no food or water

Archbishop Janani Jakaliya Luwum (aged 55, husband of Mary Lawinyo Luwum, father of nine, subjected to a ‘trial’ at a public rally, later beaten and **shot dead**)

Bishop Festo Kivengere (aged 58, husband of Mera, father of Charity, subjected to a ‘trial’ at a public rally, released)

Bishop Yona Okoth (subjected to a ‘trial’ at a public rally, released)

Bishop Wani (subjected to a ‘trial’ at a public rally, released)

Archbishop Janani Jakaliya Luwum (aged 55, husband of Mary Lawinyo Luwum, father of nine, subjected to a ‘trial’ at a **February 16, 1977** public rally led by President Idi Amin on fabricated charged of arms smuggling, later beaten and shot dead; **UPDATE**: death announced as having been in an automobile accident, body had been run over several times)

Mera (wife of Bishop Festo Kivengere, mother of Charity, fled the country after rumors of her husband's pending arrest circulated)
