India: Hyderabad, Telangana state

Kusuma Anjeneya Swamy (aged 47, husband of Sujatha, father of two daughters, engineering professor, Gideons member, verbally attacked by three Hindus for handing out Bibles on [January 21, 2017](#), dragged to a police station, released without charge, collapsed with a cerebral hemorrhage, hospitalized in a coma; **UPDATE**: reported to have been paralyzed on one side, had been threatened with being burned alive)

Rev Ronald John (State Chairman of the Telangana Christian Joint-Action-Committee; **UPDATE**: reported to have said "This is a very unfortunate incident. The ultra-Hindu nationalists are taking the law into their own hands [which] is unacceptable. This shows how minorities are being treated in this nation")

Rev M Bhaskar (reported to have said that 10,000 Christians wanted to protest against the abuse of Kusuma Anjeneya Swamy but police cancelled the protest, said "It is unfortunate that the police who are supposed to empower the citizens to exercise their right to protest peacefully [stopped the protest] contrary [to the constitution]. They showed unfair bias [against] Christians")

Timothy Ganupalli (reported to have said "We want to hold peaceful protest rally. Having a peaceful protest rally is not against the law of the land, but what prompted the police to deny the permission for the rally? It is our right")

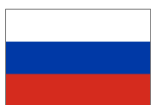

Iraq: Erbil, Kurdistan

Archbishop Bashar Matti Warda CSSR (**UPDATE**: temporarily barred from entry to the United States, Congressional hearing cancelled in response, said "I don't know what the president knows about security risks as they relate to the 'countries of concern' and refugees from them...One other thing: Christians and other minorities have been largely ignored by the American government before now, so even if this step had a bumpy start and required clarification, we in Iraq appreciate that an American administration understands that we are here and wants to help the minorities here who have suffered so much...From my perspective in Iraq, I wonder why all of these protesters were not protesting in the streets when ISIL came to kill Christians and Yazidis and other minority groups. They were not protesting when the tens of thousands of displaced Christians my archdiocese has cared for since 2014 received no financial assistance from the U.S. government or the UN. There were no protests when Syrian Christians were only let in at a rate that was 20 times less than the percentage of their population in Syria. I do not understand why some Americans are now upset that the many minority communities that faced a horrible genocide will finally get a degree of priority in some manner...I would also say this, all those who cry out that this is a 'Muslim Ban' - especially now that it has been clarified that it is not - should understand clearly that when they do this, they are hurting we Christians specifically and putting us at greater risk. The executive order has clearly affected Christians and Yazidis and others as well as Muslims. Here in Iraq we Christians cannot afford to throw out words carelessly as the media in the West can do. I would ask those in the media who use every issue to stir up division to think about this. For the media these things become an issue of ratings, but for us the danger is real. Most Americans have no concept of what it was like to live as a Yazidi or Christian or other minority as ISIL invaded. Our people had the option to flee, to convert, or to be killed, and many were killed in the most brutal ways imaginable. But there were none of these protests then of ISIL's religious test. Our people lost everything because of their faith - they were targeted for their faith, just like the Yazidis and others too. Now these protesters are saying that religion should not matter at all, even though someone was persecuted for their faith, even though persecution based on religion is one of the grounds for refugee status in the UN treaty on refugees...From here I have to say, it is really unbelievable. It is exactly this reasoning, that religion should not be a factor at all in American policy, that has resulted in Christians and other minority communities being overlooked by U.S. and UN aid programs")

Wilson Chowdhry (Chairman of the British-Pakistani Christian Association, said in [London, United Kingdom](#): "I met with the First Minister at The Pakistan High Commission last Friday and he has informed me that a trial date for Asia's appeal is sure to be fixed before the end of March. We organized the protests across the UK to galvanize support for Asia in the west. Its clear by the huge numbers of protesters calling for her hanging in Pakistan, that most Pakistani's want her dead. Moreover, the last judge retired from his position after refusing to preside over her case in a court debacle when he stated the reason for the adjournment was a conflict of interest. We want Asia to know the world is following her case and supports her freedom so we have collaborated with partners across the UK to make sure her plight is kept in the international spotlight. Our belief is this is the only way to save her from the fundamentalists who wish to see her dead")

A Pakistani refugee family who fled their home in December 2013 has been approved for immigration to the U.S. but their resettlement is now on hold for 120 days, are afraid they might be incarcerated for overstaying their visa

Cyril Kamran (husband of Samina, father of two aged 17 and 9, said "...the health condition of me and my wife is not good, my left hip joint is artificial and from last one year I feel severe pain. In my last medical examination at Bangkok Christian Hospital arranged by IOM, they identify that the joint is loose and that I need surgery again but the surgery needs time so that's why they advise me that we will refer your case to U.S. for surgery. Due to that pain I am unable to lay on the even on a comfortable bed so how can I spend one week on the floor of IDC...My daughter is 17 years old and we are unable to take risk to send her to IDC because in past, we heard so many sexual harassment cases in IDC")

Samina (wife of Cyril Kamran, mother of two aged 17 and 9, has suffered from Autoimmune Hemolytic Anemia, steroid use has affected her heart and immune system, has been afraid of incarceration)

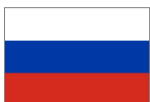

I noticed another two masked men were waiting inside a grey car near our house...The men went back inside to find my husband. I heard him plead, ‘I’m a sick old man,’ but they didn’t respond. They shot him twice in the head. Then they came out and asked me if I am a Christian. I said I was, then they asked me what my relationship was to the two men. ‘They are my son and husband,’ I told them. They asked their names and I answered. One of them was holding a list of many names and when I gave their names, he looked at the list and ticked them off with a pen...They looted the house and put the stolen things in their car before setting the house on fire. They took about 40 minutes. We’re the only Christian family on the street. I was alone - none of the neighbors helped me - they heard the gunshots but were afraid to come out. I didn’t know what to do. I went back inside and saw the bodies of my son and husband. It was horrific...There isn’t a security plan to protect Christians. The men took 45 minutes. Where were the police while they did this? And the vet, Bahgat William Zakhar, who was killed in front of people during the busy hours of the day, while those who killed him walked 300 meters down the street shouting ‘Allahu akbar’ [Allah is the greatest]. Where was the security? The security failure in North Sinai made those militants target us”)

Petr Jasek (aged 53, husband of Wanda, Czech citizen, arrested in [Khartoum](#) in [December 2015](#) for making a video for Voice of the Martyrs on Christian persecution and financially aiding a wounded Christian; convicted in [Khartoum](#) on [January 29, 2017](#) of 'waging war against the state, violating restrictions in military areas, spreading rumors to defame the state, and inciting strife between communities', sentenced to 23 and a half years' imprisonment; pardoned by President Omar Bashir during a visit from the Czech Foreign Minister, returned to Prague aboard the Foreign Minister's aircraft on [February 26, 2017](#); **UPDATE**: spoke in [Prague, Czech Republic](#) about his experiences after his arrest “The first two months were probably the most severe for me because I was placed in a cell together with members of the Islamic State, who humiliated me as a Christian. It then escalated into humiliation and physical beatings, and psychological torture and humiliation”, had been moved five times between "terrible" prisons, once was placed in a refrigerated cell)

Abdulmonem Abdumawla Issa Abdumawla (convert; **UPDATE**: still in captivity despite his conviction as an accomplice of the now-pardoned Petr Jasek)

Egypt: el-Arish, Sinai

Mina Magdy (Sinai University dentistry school student, has been living in a Coptic church with 70 other Christian students after the recent increase in the murder of Christians began, said “They [university officials] kept reassuring us that the situation is safe and ignoring our demands [to transfer]. Now, we’re too scared to go. What are we supposed to do? I only have one semester to go, but others still have two or three years left until graduation. What are they going to do?”)

Egypt: Ismailia

Fr Kirillus Ibrahim (confirmed that more than 100 Coptic families have fled the Sinai due to recent killings)

Sefein Morkos (aged 89, fled his home after receiving death threats, said: “What a shame. After 55 years in Arish, I leave it fleeing with nothing but the clothes on my back and my cane. I can’t believe it. I can’t believe it...I lived in Arish for 12 years under Israeli occupation. They never did anything to us. Now this is happening to us, and the government is silent and unable to protect us! I have been through a lot in my lifetime, and I fought for Egypt. But what I’m experiencing at the end of my life is unfair. I can’t live anywhere but Arish. It is my land”)

Angele Attia (widow of Attia Shehata, mother, fled her home in el-Arish after receiving death threats)

Said Sameh Adel Fawzy (aged 35, plumbing supply salesman, nephew of Saad Hanam, described his uncle's and cousin's murder)

Wafaa Fawzy (sister-in-law of Saad Hanam, said “They’re thirsty for the blood of any Christian. They were pretty clear when they said they won’t leave any Christian in peace. They want an Islamic state”)

Maher Fayeze (nephew of Saad Hanam, said “My uncle and cousin were killed in their house. After they killed them, they burned the house and left. All of these killings occurred in 10 days, and the targeting of Copts is constant. We want to be able to live. The country is shutting us up so that the government doesn’t look bad and seems to be in control. Any talk of security control is lies...At first, they [the police] would say that they [the Islamists] are outside of the city. How were these extremists, most of whom are young men in their 20s, able to enter the heart of the city which is studded with military, police and intelligence? And how are the weapons passed to them?”)

Sameh Mansour (civil servant, son-in-law of Saad Hanam, fled his home in el-Arish after receiving death threats, said “Now that the killing has become daily, the media has taken notice...Since the January 25 revolution, we’ve been dying slowly. We can’t go to our jobs or live a normal life with our kids. We can’t sleep or eat”, told that his request for a transfer to a less dangerous location would not be approved by the government)

Nermeen (aged 9, sister of Nancy, relative of Saad Hanam, fled her home with her mother)

Nancy (aged 7, sister of Nermeen, relative of Saad Hanam, fled her home with her mother)

Awatef (said to a priest “No, your holiness. This suffering is too much and we are tired. Which god would allow this torture? Enough with the talk that doesn’t mend the wounds! Our children and men are being killed in front of us. We fled our homes and you’re still repeating that God is consoling us, and then you return to your homes and your churches

away from us....Where is the [Coptic] Pope? And where is our Bishop Kosman [the bishop of the North Sinai dioceses] who shut the door of the cathedral on our faces when we asked to hide there or at least put our children there. We see Syria and Iraq on television, but we see no coverage of Sinai, except for lies”)

Ezzat Yacoub Ishak (blacksmith, fled with his two sons, said “The security forces, they’re all hiding and scared for their lives, scared to confront those people. There is no security. Yes, there are military and police at the check points, but for my protection as a human there is nothing”)

Mina Misak (aged 20, son of Misak Nasrallah Misak, father shot dead in 2016 as he left his hospital, said “It tore me to pieces when I found out, and now it’s even worse - there’s no reason to stay. It’s difficult to do anything. Most of my friends and family have left. And Muslims are scared too, of course”)

Nabil (fled his home, said “In el-Arish, there are seven checkpoint buildings lining the road to town, but inside, you hardly see a soldier. Whenever there’s an attack they come after we telephone them, sometimes days later, and ask for descriptions of the killers. But that’s all”)

Reda (parent, grandparent, civil servant, said: “I don’t want to stay there and die as a casualty in the war that has hit el-Arish. If they allow us we will stay here until the terrorism is over and the government makes peace”)

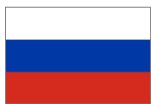
Fayez (shop owner, fled his home, said “Hopefully we’ll find a home and be able to stay here, but I don’t know how I would move my business. Daily life looks normal in el-Arish, until you hear about terrorists shooting people in their own homes”)

Nabil Shukrallah (church worker, said that more than 100 Christian families have fled the Sinai, said “They’re exhausted, with urgent needs for food and children’s clothing. They’re terrified of the violence and brutality”)

Palestine: Gaza

Fr Mario da Silva (Brazilian citizen, pastor of the only Latin-rite Catholic church in Gaza, said of his 350 families "The situation in Gaza is hard. After the [2014] war, we received international aid. However, six months later they forgot about us, as if everything had been resolved. Instead, problems remain, like the lack of jobs, gas, water, and electricity. On some days, there is electricity only for three hours. It's cold here and people do not know how to heat their homes. We have no drinking water because what comes out [of the tap] is salty, hence, we have to buy bottled water...People here are starting to think seriously that it would be better to get into another war because then at least there would be aid. It is a sad and terrible thought but it shows how tragic things are. The world pays attention to us only when there is a war...The young people who were authorized to visit the holy sites in Jerusalem and Bethlehem last Easter did not return. They remained in the city where Jesus was born and found a job, laying the foundations for a new life. That is why, here, people want to leave...Christians live mainly with debts, buying on credit from the supermarket and promising to pay later. Christian charities help out by paying off the debts. The jobless are forced to beg and count on the generosity of others...Preserving the Christian faith is the foundation of our social work. We have to give them a decent life. Our attention goes to the sick, the suffering, those in difficulty with this spirit...preserving the integrity of the faith, defending it, and teaching Christians how to live amid hardships and a Muslim majority...upholding Christian values like forgiveness, charity, and fraternal love is hard. That is why Christians here are heroes. They know how to keep the faith in a hostile environment and stand more and more as an example for those, even in the West, who experience dimly and superficially their Christian faith")

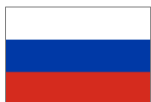

If we want to live in peace, we have to accept the damage done to each other")

Shahid Anwar, diocesan coordinator for Justice and Peace, said "Very often this kind of allegations is levelled against Christian domestic workers by rich home owners because they belong to minorities and marginalized groups. Most of the time, the charges are unfounded. Employers do not want their employees to free themselves from their bondage. The daughter was held at the Tariq home and her father was kept behind bars for many days without due process. This family is innocent and very poor. We are providing them with legal aid, and managed to get interim bail at the High Court in Lahore, but we hope that on March 6 the bail will be confirmed. We stand by these poor victims and shall fight until justice is done")
