Venezuela: Maturin

Bishop Enrique Perez Lavado (said "The situation in the Country is dramatic, there is no food and people have reached the limit of tolerance. The attitude of closure of Nicolas Maduro's government only aggravates the context. The Bishops' Conference and Venezuelan Caritas continue to make proposals to establish an aid channel. Many Caritas from other countries, as well as other NGOs, are willing to help us by bringing medicines and food. However, the Government hampers any kind of intervention. I happened to see miles of people in a row to buy food. Hundreds of people are dying, including many chronically ill children")

Pakistan: Umerkot

Irfan Masih (aged 30, sanitation worker, suffocated while in a sewer, died at the hospital after doctors refused to treat him because of the sewage on his body)

Pervaiz Masih (sanitation worker, cousin of Irfan Masih, said "I was heading to work when I was informed about the incident. I rushed to the scene and saw that some passersby had already pulled out Shaukat Masih from the manhole. I then helped them bring out Yaqoob and Irfan. Irfan was breathing, sometimes choking a bit. I carried him on my shoulder and started running towards the Civil Hospital when a rickshaw pulled over to help me carry him...I kept pleading with the doctor on duty, Yusuf, to begin Irfan's treatment, but he refused, saying he was fasting and that his Roza [fast] would get makroo [invalid] if he touched the filth-covered body of the sanitary worker. Irfan was alive for over half an hour. He was breathing all this while, but the doctors lost precious time by refusing to treat him. They are responsible for his death on the hospital bed")

Nasir Saeed (**UPDATE**: said "A life could have been saved if medical aid had been given in time. This is not the first time that any sewer cleaner has died doing his duty. The government should provide safety kits to their workers but since these menial jobs are reserved for the Christians nobody cares about them")

Michelle Chaudhry (**UPDATE**: said "A society becomes extremely dangerous when it becomes inhumane. An innocent life has been lost because someone refused to carry out his duty, at a deontological and public service level. The doctor violated Hippocrates' oath that obliges him to treat a patient in any circumstance, beyond religion and social class")

Pastor Scott Lively (sued by a homosexual group for allegedly inciting 'a dozen minor incidents' of persecution against homosexuals in Uganda over the past decade, he denied the charges, a Federal judge ruled on August 28, 2013 that the trial may proceed; petition for dismissal denied on December 5, 2014 by a three judge panel of the Federal First Circuit Court in Boston; UPDATE: suit dismissed, issued a statement which noted the judge's 4 year delay after an April 17, 2013 U.S. Supreme Court ruling eliminated the statutory basis for the suit)

Tran Thi Hong (wife of Pastor Nguyen Cong Chinh; **UPDATE**: spoke after discovering during a family visit that her husband had been confined to a cramped punishment cell after telling U.S. diplomats on May 25, 2017 about the mistreatment he has suffered: "Chinh said on the previous day, prison officials informed him about the meeting [with U.S. diplomats] and asked him not to tell the visitors anything that would make them look bad. Chinh could not obey their order. He told the delegation his experiences of torture, threats and mistreatment that he has endured over six years")

This also reflects the mind-set of those who govern us, those in power who with their acolytes appear bent on destroying what is deemed sacrosanct in the Constitution of India...there are fewer scruples in denigrating and even exterminating minorities, Dalits and Tribals...[this is a] brutal plan to promote fascist ideologies", he demanded removal of the books and "that the perpetrators be prosecuted according to the law and that the government apologize to the Christian community")

Egypt: Alexandria

Fr Henri Boulad, SJ (aged 85, director of the Jesuit Cultural Center; **UPDATE**: said "One can say that 'Arabs' are naturally violent. But the same could be said of the Barbarians who conquered Europe in the past. These invaders have been progressively 'civilized' by the Christian faith to become what they are now. In my opinion, the religious element plays an essential role in shaping a society. The fact that Christian 'Arabs' are different than Muslim Arabs is a proof of the strong connection between religion and society...All attempts to reform Islam by liberal open-minded Muslims have tragically failed so far and I doubt that a 'reformed Islam' will still remain 'Islam'. Here are six unsuccessful attempts to reform Islam in the last two centuries [listed them in the article]...On such ethical issues [with secular societies], and others, the Church should ally with Muslims to fight against whatever demeans and degrades the human being. This is fertile ground for understanding between the two religions. It can also pave the way for us to denounce anything which is morally unacceptable in Islamic teaching")

Christina Khidr Ebada (aged 5, abducted on August 22, 2014 from her mother's lap by ISIL militants in Qaraqosh; a Christian woman named Rana in a September 2014 phone conversation after her capture by ISIL said that she had cared for Christina, said Christina was later given to a Muslim family to be raised as a Muslim; still missing as of September 9, 2016, a photograph of her appeared on Facebook before the internet was cut from Mosul; UPDATE: recovered in good health by Iraqi government forces during fighting in the Mosul area, returned to her parents, had lost the ability to speak Assyrian, has been "overwhelmed" by the welcome received at the refugee camp where her parents live)

- Pastor Victor Beth Tarmez (husband of Shamiram Isavi, father of Ram-eil, bodily searched during a December 26, 2014 police raid on his Tehran home, arrested; released from jail on bond on March 1, 2015, banned from Christian activities until his trial begins, suffered health problems while in prison; **UPDATE**: sentenced to 10 years' imprisonment)
- Ram-eil Beth Tamraz (son of Pastor Victor Beth Tarmez and Shamiram Isavi, bodily searched during the December 26, 2014 police raid on his home in Tehran; arrested without warrant by MOIS agents while fishing and picnicking with his wife in Firuzkuh on August 26, 2016; released on October 10, 2016 on a US\$35,000 bail; **UPDATE**: awaiting trial)
- Shamiram Isavi (wife of Pastor Victor Beth Tarmez, mother of Ram-eil, bodily searched during the December 26, 2014 police raid on her home in Tehran; **UPDATE**: awaiting trial)

Bishop Denis Brennan (said "There is a lot of concern in church circles these days about the future. This is understandable given the volume of criticism and negativity directed at the

church over recent times...In these Pentecost days we need to cast off our fears too, we are not the first generation of Christians to worry and wonder about the future. In every age people have written the obituary of the church and our age is no exception")

Ireland: Drogheda

Bishop Leo O'Reilly (reported to have spoken of "hostility to the church that is now a settled part of our society's culture. People from abroad are often astonished at the antipathy to the church displayed in our country...It is not physical persecution but it is no less real for that. It is more subtle. It takes the form of gradual exclusion of church people or activities from the public space. There is denigration of religious beliefs, practices and institutions on radio, television and on social and other media. There is often a focus on bad news about the church to the almost total exclusion of any good news")

Papua New Guinea: Rabaul

Doug Tennent (New Zealand citizen, missionary, attorney, diocesan administrator, expelled from the country)

Archbishop Francesco Panfilo SDB (said "Doug Tennent received a decree of expulsion on the grounds that he was 'involved in sensitive issues concerning land owners'. We know the meaning of these words: they refer to the native peoples in the area of West Pomio, in the territory of our archdiocese. In 2012 a group of land owners in that area stipulated an agreement with a Malay multinational, the Rimbunan Hijau, which grants land for the exploitation of timber and the production of palm oil. But the contract was not sufficiently examined. As the years passed the natives witnessed progressive deforesting and serious environmental devastation. Therefore, rightly concerned, they demanded fairer conditions and guarantees of protection for the area, and asked for my direct involvement in the matter, as Archbishop and a Catholic representative. We examined the question and, thanks also to the competent assistance of Mr. Tennent, we started the process of requesting a re-negotiation of the contract...The land rental agreement is clearly unfair towards the owners of the land, the rent conceded for the land is inadequate and what is more the multinational company for the past two years has been in arrears, coercive means were used to obtain the signatures of the land owners and consent for the area conceded; the local people were not properly informed...The event has caused clamor and indignation in politics and in the media. Our request to the government is to immediately recall Tennent, whose assistance is important for the administration of our

local Church. We hope the Foreign Ministry will intervene and reconsider the decision taken. We wait and hope. We are ready even to go to Court")

The U.S. Immigration and Customs Enforcement agency detained 199 Iraqi nationals for deportation, including many Christians

Pastor Jalil Dawood (said "We can't say these people went through genocide and send them back to be victimized again! We hope and pray that the issue gets resolved. America should never deport Christians to Iraq because they will be in trouble in Iraq as over a million left Iraq since 2003, and this will cause great hardship to their loved ones here [also bringing] harm to them physically, mentally, and spiritually if they [are] ever sent back. I understand that some might not have done their paperwork properly or [have] passed their datelines. But deportation is [an] extreme measure toward peaceful people that just want to survive and do well in this society [and] love America as their new home")

Bishop Francis Y Kalabat (wrote "The Church does not oppose justice, all hardened criminals that are a danger to society should be picked up. Many who were picked up are not hardened criminals but for the last decades have been great citizens [sic]. The genocide bill that was just passed by Congress last week to protect Christians goes against this very thing")

Christian construction workers were reported to have escaped from Islamic militants

Jenniver Velazques (thanked the local Muslim police:"If not for them, we would all be dead by now")

I'm a liberal to my finger tips, and that liberalism means that I am passionate about defending the rights and liberties of people who believe different things to me. There are Christians in politics who take the view that they should impose the tenets of faith on society, but I have not taken that approach because I disagree with it - it's not liberal and it is counterproductive when it comes to advancing the gospel. Even so, I seem to be the subject of suspicion because of what I believe and who my faith is in. In which case we are kidding ourselves if we think we yet live in a tolerant, liberal society...")
