Dilip Bhadur Gurung (police constable, arrested for talking about Christianity at a public religious gathering, will likely be denied a promotion for 5 years)

Pastor B P Khanal (**UPDATE**: said of the arrest of Dilip Bhadur Gurung: "It is a kind of injustice – if he was talking about Hinduism or Buddhism, he would not have faced any problem. Taking the name of Jesus is risky in public-speaking; it is an offense against the law. People are biased and are looking for an opportunity to arrest Christians...Nepal law discriminates between Sanatan and others. Freedom of religion or belief is to be ensured for all, but the new criminal code ensures the freedom only of Sanatan Dharma, 'the eternal tradition,' or the 'eternal way' Hindu majority. By its language and meaning, it doesn't tolerate religious activities of minorities except the Sanatan. Practicing, teaching and doing good [acts of welfare] by 'others' are criminalized'

Nigeria: Ariri village, Plateau state

#### Nineteen Christians were killed and three wounded by Fulani Muslim gunmen

Samuel Wah (aged 45, widower of Laraba Samuel, father of Reizeh, Wah, Jummai, and Wei, brother of Monday Wah, shot in the back, said "I moved to the door of my living room and then opened it, only to find a Fulani man standing and aiming the gun towards where I was standing. He shot me...After shooting me, the Fulani man then shot my wife and children. All of them were killed. They must have thought that I was dead too, and so moved out of my house", hospitalized)

Some soldiers got out of the vehicle and started shooting...The military tried in vain to open the door [to

the sacristry where parishioners had taken refuge], then they approached Gerard lying on the floor and ordered him to get up, which he did hesitantly. [After interrogating him] they shot him three times in the neck and he died instantly")

# Pakistan: Lahore

Anil Saleem (aged 27, brother of Kiran Saleem [who was killed by doctors, male nurses, and hospital security personnel on March 26, 2018]; UPDATE: reported that no arrests had been made in the murder of his brother, said "Moreover, the police exonerated the main accused, Dr. Saira, in the initial investigation, even though she was the one who had instigated her colleagues and the security guards to attack us in the hospital ward...We think that the police were told by the provincial government not to arrest the doctors to avoid confrontation with the YDA [Young Doctors Association, which had threatened a strike if prosecutions went ahead]...They have made several attempts to settle the case through money, offering up to 2 million rupees [US\$26,905], but I have refused to take the money. No money can heal the wound we have suffered. I have told the accused that I will not withdraw the case until all of them, including Dr. Saira, are put behind bars. How can they just absolve Dr. Saira, when it was she who had instigated the attack in the first place? The court has directed the police to re-investigate the case, but they are delaying presenting the report on one pretext or the other")

# Seventy adult Pakistani Christian refugees and scores of children were arrested for immigration violations

Mona Sumbal (teacher, hid in a boiler room to avoid arrest, later said "I had not even woken up when I heard shouts and screams as people began to warn others to escape. Our community is protective of one another and for many the first thought was help others slip the arrest that would place them into brutal incarceration in Bangkok IDC [Immigration Detention Centre]. I heard the children I teach weeping and my heart was broken, I wanted to help but knew that if I came out of hiding I would be arrested too and the end result would be a return to Pakistan where my life is at threat. I just hunkered down closed my eyes, covered my ears and prayed to God to save me from arrest. He was my only hope. I waited an hour after all the noise had dissipated and discovered our school had been destroyed and no-one was around from the community everyone was arrested. I felt isolated and alone and broke down and wept as I fell into a deep

depression. About 20 mins later my cousin appeared she is only 18 and now from such a large community only the two of us remain free. I feel helpless and have been crying constantly this latest raid has left me in a position I have never been in before, one where I no longer have the safety and protection of my family")

Adnan Masih (aged 32, husband of Sumaira Adnan, father of two, Pakistani asylum applicant, detained in Phuket on July 3, 2018 while on the way to work; **UPDATE**: still detained)

Sumaira Adnan (aged 29, wife of Adhan Masih, mother of two aged 4 and 9, Pakistani asylum applicant, as of July 3, 2018 has worked as a teacher at an underground school for the children of asylum seekers; UPDATE: detained with her two sons, later said "In a morning I woke up to make food for my husband because he is in IDC [Immigration Detention Center] I was near the lift when I heard voices. They were all crying and screaming so I ran back to my room but then the police came and arrested all of us, took us down to the trucks and put us in IDC...My husband was very stressed inside the IDC but when I was arrested too, he became more tense and upset because we don't have any relatives or any people who can send us food or supplies that we might need. My husband is also not well because two years ago he had an accident at work so he does not walk well and now he has scars on his legs - he is in very bad condition")

They told us that neighbors are disturbed by our singing and praying. I told them that the noise levels are always under control, and that we have been worshipping for the past two years, and the neighbors never raised any such issues"; **UPDATE**: summoned to the police station to meet with the complainant, said "Uma Mageshwari is a neighbor who has close links with RSS [paramilitaries]. About a week before police came, RSS activists had put up a pole in the church premises and attached a saffron flag to it. They refused to remove it, and we informed the police. They [RSS activists] kept watch of our coming and going every day. They still do")

Souleman Yusph (journalist, disappeared in Qamishli on September 30, 2018, believed to have been detained by the Asayish [the Kurdish security and intelligence service], had extensively reported on Kurdish closure of Christian schools; **UPDATE**: reported to have been released, in seclusion at home)

Archbishop Jacques Behnan Hindo (UPDATE: spoke on the release of Souleman Yusph: "It is understandable that he wants to keep a low profile, but I want to continue to speak out against the discriminatory campaign by Kurds against Christians in the north-eastern Syria. He was arrested simply for telling the truth, for denouncing the abuses...more targeted attacks and violent incident cannot be excluded. We can expect anything from the Kurdish authorities. They do not understand that they are pawns in the hands of the West and are used for political purposes", added information about an upcoming meeting he will have with a Kurdish delegation: "it will be a tense meeting...They know that I am against their way of doing and governing the region. The major problem is not the Syrian Kurds, but those who come from Turkey and Iraqi Kurdistan who want to annex ancient Mesopotamia to their territory")

#### **United Kingdom: London**

Daniel McArthur (husband of Amy McArthur, owner of a bakery in Belfast convicted on May 18, 2015 of discrimination for refusing to provide a cake with a pro-same sex marriage message, fined US\$786; UPDATE: conviction overturned by the Supreme Court, said "I want to start by thanking God. He has been with us during the challenges of the last four years. Through the Bible and the support of Christians, He has comforted us and sustained us. He is our rock and all His ways are just...We're delighted and relieved at today's ruling. We always knew we hadn't done anything wrong in turning down this order. After more than four years, the Supreme Court has now recognized that and we're very grateful. Grateful to the judges and especially grateful to God...We're particularly pleased the Supreme Court emphatically accepted what we've said all along – we did not turn down this order because of the person who made it, but because of the message itself...The judges have given a clear signal today. In fact, it couldn't be clearer. 'Family businesses like ours are free to focus on giving all their customers the best service they can – without being forced to promote other people's campaigns.'")

Dr Katarzyna Jachimowicz (Polish citizen, fired from her job in Sauherad in 2016 after refusing to implant IUDs; an appellate court in Skien ruled on November 24, 2017 that her termination was illegal; UPDATE: appeal upheld by the Supreme Court, attorney stated "Today's Supreme Court decision marks an important step in the right direction, not only for doctors, but for people of faith in all professions. After they poured petrol on me, miraculously there was a [power] blackout. And within minutes, police reached the spot and rescued me", charged with 'promoting enmity between different groups on grounds of religion' and 'criminal intimidation' after RSS paramilitaries complained to police, denied bail, found his wife and children had been rescued from the mob by hospital personnel and his ill son received treatment)

#### Pakistan: Islamabad

- Aasiya Noreen aka Asia Bibi (aged 53, wife of Ashiq Masih, mother of five including Isham, daughter of Soran Masih, convicted of blasphemy in 2009 and sentenced to death; **UPDATE**: the Supreme Court issued a ruling that overturned her conviction on the grounds that she had been denied presumption of innocence, ordered her immediate release, reports tell of government preparations for civil insurrection)
- Mehwish Bhatti (British Pakistani Christian Association officer; **UPDATE**: said "We are so happy and thankful to God for this big day! All glory goes to Him. The decision was tough: God has strengthened the resolve of the Justices and has made it possible. I pray for the peace of minorities, let God be their guardian")
- Peter Jacob (director of the National Commission for Justice and Peace; **UPDATE**: said "Indeed it is a happy moment for Asia's family, the Christian community, and Pakistan as she is acquitted by the Supreme Court. The decision raises hope for the rule of the law and justice. The charges against Asia were false and based on a narrative of hatred, hence the Supreme Court has dealt with the case on merit")
- Sajid Christopher (President of Human Friends Organization, said "Truth prevailed. Justice has won. Asia will be leaving Pakistan immediately after her release for her safety")
- Samson Salamat (chairman of the interfaith Rawadari Tehreek [Movement for Tolerance]; UPDATE: said "The decision of Supreme Court in favor of Asia Bibi is evidence that blasphemy law is being used against religious minorities of Pakistan to settle personal scores. The justice system at the Lower level looked very weak and ruled against Asia Bibi under pressure of the extremist elements, however the judges of the Apex Court are to be appreciated who did not bow to pressure of the hardcore Tehreek Labbaik Pakistan [TLP] and other extremist outfits. Asia Bibi is acquitted but the sad part of the story is that she will not be able to live in her own homeland because of threats to her life similar to many other cases. The story does not end here, there is an extreme level threat to the Christian Community and their lives, worship places and properties are in danger", also issued a press release stating "This is a highly tense and threatening situation for religious minorities, especially for Pakistani Christians, and there is fear of persecution of Christians and attacks on their churches and other properties. Therefore, we call upon the government of Pakistan and the Supreme Court to take notice of the threats made by [TLP leader] Khadim Rizvi and his group prior to the announcement of the Asia Bibi verdict. We also call for a ban of Tehreek-e-Labaik and all similar extremist groups who are involved in hate speech and use religion as a tool to promote violence in society. We also call upon the government and law enforcement agencies to beef up security and ensure the deployment of military troops to safeguard the lives and property of religious minorities, especially the Christian community")
- Michelle Chaudhry (president of the Cecil & Iris Chaudhry Foundation; **UPDATE**: said "Today the Supreme Court has shown great mettles by taking a firm stand on justice and civil liberties. However, this verdict may have chilling ramifications, as the threatening warnings of Khadim Rizvi [leader of Tehreek Labaik Pakistan], a flamboyant hate monger, are making the air thick with fear of another bout of anarchy. Exciting religious emotions, they can create situation of law and order, which Pakistan can't afford, given its financial woes. While the acquittal offers a sigh of relief, it may inject more blood in

the already swelled up veins of extremists. What the government should do? It should not give in to hate mongers, as they will find it an opportunity to further their agenda to control the state. Parents should keep an eye on their young children lest they should be used by these extremists for their nefarious design to destabilize the country")

- Nasir Saeed (**UPDATE**: said "While we are rejoicing the acquittal of the Asia Bibi, at the same time we are very concerned about the ongoing security situation in Pakistan. Christians who are a beleaguered community and are living under constant fear for their lives are further threatened because of the present situation")
- Samuel Piyara (Implementation Minority Rights Forum chairman; **UPDATE**: said of Prime Minister Imran Khan's televised address in support of the Supreme Court ruling freeing Asia Bibi "The cricket hero [Prime Minister Imran Khan] took the bull by the horns. Nobody can take the state hostage")
- Joseph Francis (Pakistan Christian National Party chairman; **UPDATE**: thanked Prime Minister Imran Khan for his televised address in support of the Supreme Court ruling freeing Asia Bibi and added "We humbly request government security agencies to take action against the fanatic groups who create problems for the whole nation. A police first information report must be launched or legal action should be taken against them")

Ever since her appointment three years ago, the headmistress has picked on him...She asked me to grab her feet for the mistake of my son and threatened that her brother, a police officer, would sell my younger daughter to a brothel...We are now being threatened and approached by the family of the principal as well as local politicians", reported the incident to the government)
