Brother Ronald Brown (church sponsored teen conference on sexuality cancelled by the local government-owned civic center after objections were raised to the speaker list and the conference name 'LGBT: Let God Be True', said the controversy over the name “shows that something is amiss in society...Is there a patent on that acronym?...Our teaching is based on the word of God, and whatever the word of God says, that's what we're going to be expounding...We see ourselves, the church, as a hospital, right? That's where people who are sick and in need of help come”, has threatened a lawsuit if the cancellation is not reversed)

**UPDATE:** church gate padlocked by the government, parishioners were denied entry to retrieve belongings)

They are preparing for further suppression by touching base and collecting information. This is only the start”)

People from the religious affairs bureau found me to question me”, questioned and released, five or six other Christians were still in detention)

**Event: A petition for the release of seven Christians falsely imprisoned for the 2008 murder of Swami Laxmanananda Saraswati has reached 50,000**

Pastor Arul Ruben (aged 37, church destroyed by arson, said “I received the call around 8 p.m., immediately asked the local pastor in Paramankeni to continue the service and rushed to Seekanankuppam. In 20 minutes I was able to reach it, but by that time, nothing was left – the fire had spread all over...[Last year] they humiliated the Christians for their non-participation [in a Hindu festival] and issued threats that the church would be destroyed if any Christian refused to contribute to the Hindu temple for the annual celebration of their deity. Even this year, they visited the Christian families and asked them to donate for the celebration, but nobody contributed. When the festival is over, just when we were glad for the peace and harmony around us, we get to see the church turn to ashes”)

Pastor Benjamin (said the locals had demanded the church property be used for a cemetery right-of-way and commercial development “Behind the church, the Hindu residents from nearby villages demanded that the church be closed down so a short-cut way can be paved for Hindus taking their deceased for cremation. They even carried the dead via the church premises to the cemetery. They stopped after the area president intervened and warned them that it is not right, and that they must avoid entering the church premises and take the long route instead...The area is in demand because of the ECR route, and random businessmen and real estate dealers constantly ask us to vacate. They told us the land can be of best advantage for commercial use”)

Pastor David Santosham (church destroyed by arson, later said “It has been nearly two months, and police could not find the culprits. I met the sub-inspector of police recently, and he told me that the investigation is underway. We are building the church again by the grace of God. Please pray for the construction work”)

Location: Puducherry, Karaikal district, Tamil Nadu state

Pastor Govrathnam Anbarasan (church destroyed by arson, later said “That week, we conducted a VBS [Vacation Bible School] program for children in the church. There was opposition from Hindu fundamentalists in Thiruvannamalai, but we continued the church services...As the roof was woven with coconut leaves, it is enough to ignite a small portion [after the children left] and the fire can spread all over easily in short time. I was visiting a believer’s family about three miles away to pray for their son...Since the past two months, we have been worshipping in open air under a tent. A relief organization had come forward promising to help, but I received nothing from them. We don’t have enough means to rebuild the church, even if temporarily”)

P S Nehemiah Christie (**UPDATE:** said “On one side, we see the Hindu extremists barging inside the churches and attacking pastors, and the other side is what goes on behind us – in remote areas, they are burning away churches, especially those with roofs of tar sheet

or coconut leaves, so fire can be spread speedily and easily, and before anybody can notice the perpetrators, they escape from the spot...The brotherhood Tamilians share irrespective of their caste or religion is today under threat, with political figures attempting to spread hatred against Christian and Muslim minorities for their political agenda. In every case of arson, the police conveniently register it as fire accident due to short circuit, and they refuse to register the suspects' names. But in reality, it is targeted violence to create communal disharmony between the Hindus and Christians")

**UPDATE:** organized a demonstration in which 10,000 Christians formed a 20 kilometer human chain to protest anti-Christian activities, said "Catholic nuns, priests, pastors are attacked and jailed. Their institutions are searched. They are accused of every wrong that takes place in the state...It is part of an organized to plan to keep ordinary people away from Christian institutions and missionaries")

Ankita Kujur (protester, said the Hindu nationalist state government was trying to politically weaken the indigenous tribal people by dividing them into opposing Christian and non-Christian camps)

**Event: Christians denounced calls by Hindu radicals that Mother Teresa be stripped of her government awards in the wake of an illegal adoption scandal at one of her order's orphanages**

Sr Sister Mary Prema Pierick MC (Superior General, issued a statement alleging that the illegal act was perpetrated by an orphanage employee who hid her actions from the nuns, also stated that the scandal could have been avoided if the government child welfare agency acknowledged to the orphanage in writing that a child had been placed for adoption)

Bishop Vincent Barwa (**UPDATE:** said "The entire world knows the good work Mother Teresa did for humanity, especially the poor")

Fr Denzil Fernandes SJ (Executive Director of the Indian Social Institute; **UPDATE:** said the attackers "could not stomach the good work the nuns are continuing to do. It is their agenda to target the church")

Abraham Mathai (**UPDATE:** said at the most, the nuns are guilty of naivety and overtrusting people" and that media and police are "ridiculously and shamelessly" accusing them)

A C Michael (United Christian Forum; **UPDATE:** said that Mother Teresa had been granted honors for her merit and so "It is unfair to demand to take them away for the alleged wrongdoing of her nuns")

Auxiliary Bishop Theodore Mascarenhas SFX (**UPDATE:** said "What has this to do with Mother Teresa and the Bharat Ratna [award]?...There has been a lapse at the MoC home. It should have never happened. The MoCs have admitted it", alleged that the investigation was a "conspiracy behind blowing up the isolated case in the MoC home to discredit the MoCs and Christians...[the scandal cannot be seen in isolation from the several incidents in which the BJP government has been hostile to the Christian community"]")

## Iran

Ram-eil Beth Tamraz (son of Pastor Victor Beth Tarmez and Shamiram Isavi, arrested without warrant by MOIS agents while fishing and picnicking with his wife on [August 26, 2016](#); released on [October 10, 2016](#) on a US\$35,000 bail; **UPDATE:** convicted of 'acting

against national security' and sentenced to 4 months' imprisonment [of which he has already served 2 months], appealed)

## Macedonia

Archbishop Jovan of Ohrid aka Zoran Vraniskovski (aged 54, arrested on [December 13, 2011](#), at the [Bitola](#) border crossing; sentenced on [July 3, 2013](#) in [Skopje](#) to three years in prison and church property seized for alleged money laundering, charges widely viewed as resulting from his efforts to reunify the Serbian and Macedonian Orthodox Churches; released from prison on [February 2, 2015](#); retrial continued on [March 11, 2016](#), the prosecution's chief witness has disappeared, the court has continued to reschedule hearings for two months for the purpose of delay and has refused to allow the Church to use its frozen but empty bank accounts nor open new accounts; **UPDATE**: passport seized at a border crossing, prevented from leaving the country)

## Nicaragua

Bishop Juan Mata Guevara (shot at by pro-government paramilitaries at a police checkpoint while in his vehicle, escaped injury, tires and windows destroyed, took refuge in a house and prevented from leaving by hostile government supporters for 90 minutes, returned home)

Fr Jairo Velasquez (rectory raided by police and paramilitaries, parish and personal property taken)

Fr Erick Alvarado Cole (anti-government protesters and journalists took refuge in his church after two were killed, said "They are shooting at a church. The government says it respects human rights. Is this respecting human rights?", pro-government paramilitaries prevented ambulances from arriving)

## Philippines

Jennifer Taborada (aged 27, widow of Ryan, mother of Prince Junior and Princess, **shot dead** apparently for leading a diocesan support group for the widows of men killed in the government's extrajudicial campaign against illegal drugs)

Bishop Pablo Virgilio David (**UPDATE**: said after the murder of Jennifer Taborada: "I feel so, so, so, so sad that I am not able to protect my flock from the wolves. Today, in utter shame and frustration, I declare I have not been a good shepherd to my flock. The wolves, they have been prowling the streets and alleys of [the Manila suburbs of] Caloocan, Malabon, and Navotas for almost two years now. They have killed hundreds already, and I am unable to protect them with my life...I will bow in shame if the Good Shepherd will denounce me as a mere hireling who remains very safe and very secure, who can get a good night's sleep in his warm bed while his sheep are being slaughtered")

## Rwanda

**Event: The government has closed over 700 churches and has introduced legislation that would require all clergy to have four year college degrees**

Jean Bosco Nsabimana (asked why the government was not closing bars and nightclubs)

Bishop Evalister Mugabo (has taken steps to ally his Bible school with a university in Tanzania, said "We made this plan because we can't afford to take many pastors out of the country for study at once. We do not have enough resources, so we decided to adopt mass training from within...Most of the pastors have certificates from local Bible schools. Global missions must look at this as an emergency")

## Turkey

Pastor Andrew Brunson (U.S. citizen, husband of Norine Brunson, detained as a 'national security risk' in [Izmir](#) on [October 7, 2016](#); confirmed to be a hostage at a [September 28, 2017](#) press conference by President Recep Tayyip Erdogan, the President explicitly called for the U.S. government to exchange him for Sufi cleric and U.S. resident Fethullah Gulen; **UPDATE**: denied bail, told the judge “It is really hard to stay in jail and be separated from my wife and children...There is no concrete evidence against me. The disciples of Jesus suffered in his name, now it is my turn. I am an innocent man on all these charges. I reject them. I know why I am here. I am here to suffer in Jesus’s name...My faith teaches me to forgive, so I forgive those who testified against me”)

Kristina Arriaga de Bucholz (U.S. Commission on International Religious Freedom [USCIRF] Vice Chair, attorney, attended the hearing, later said “The government of Turkey continues to make a mockery of justice in its treatment of Pastor Brunson. Today I was hoping to see the judge order his complete release and put an end to the miscarriage of justice that Pastor Brunson’s entire case represents. Turkish authorities still have not provided one good reason for depriving Pastor Brunson of his liberties”)

Pastor Richard Smith (forced to resign as mayor of his town [on or about July 4, 2018](#) after outrage over his posting of Biblical statements on his Facebook page; **UPDATE**: a vote to remove him from the Town Council was defeated)

Sir Edward Leigh (Member of Parliament, raised the issue of the denials of a visa for Sr Ban Madleen in the House of Commons, the visa was then granted within hours)

Jacob Rees-Mogg (aged 49, Member of Parliament, **UPDATE**: raised the issue of the denials of a visa for Sr Ban Madleen in the House of Commons)

Bishop Marcus Stock (criticized a report on religious education [RE] by a former Education Secretary and a professor “Not only are their recommendations largely incompatible within our sector, they were compiled with the knowledge that the Catholic community would find them unacceptable, this was explicitly stated in their report...Firstly, [it is wrong] that the State can impose a national RE curriculum, which would dictate what the Church is required to teach in Catholic schools. Secondly, the curriculum they suggest contains no theological content, which is at the core of Catholic RE...Catholic schools are the most successful providers of Religious Education in the country. This is because we take it seriously as a rigorous, theological academic subject. However, rather than look at the sector that does it the best they have opted for a reductionist approach which is exclusively sociological and has no consensus amongst RE professionals”)

### United States - Texas

Bishop Edward J Burns (expressed thanks after a Federal appellate court reversed a district court ruling to compel the Catholic bishops of Texas to release their private emails regarding abortion, “We believe that life is sacred from the moment of conception. We also believe that we have a right to discuss in private how to address this issue and uphold the dignity of every human life, and that while upholding the sacredness of life may seem at odds with some people, our religious liberties and religious rights should not be eroded”, the bishops were not a party to the suit by abortion providers against the state law requiring funeral internment of aborted remains but had only stated they would provide free burial in Catholic cemeteries)

### Vietnam

Mary Magdelene Nguyen Ngoc Nhu Quynh (aged 39, mother of two, sentenced in [Nha Trang, Khanh Hoa](#) province on [June 29, 2017](#) to 10 years' imprisonment for anti-government internet postings, which included criticism of hospitals refusing to serve the poor;  
**UPDATE:** denied a Bible, began a hunger strike to protest deliberate food poisoning, harassment by fellow inmates, and use of a toilet with no privacy, in poor health)
