### China

Liu (church leader of two churches, village church service interrupted by two government officials, said “They want to tear down the cross. I made it clear to them that the cross must not be dismantled. They said they didn’t mean this and asked again whether or not we could hang the national flag. Now, they have conceded...The church [downtown] unanimously opposed the cross dismantling. They asked the religious affairs bureau ‘By which law do you dismantle our cross? Law enforcement should be carried out in accordance with legal procedures.’ The authorities also said that [we] could not bring children to church, that there were policies [opposing this]. I said, ‘Your policy is in conflict with the Constitution. When the children are born, they are citizens of the People’s Republic of China, and they have freedom of belief. Children’s freedom of belief cannot be interfered with. They can follow their parents’ beliefs”)

## Egypt

Maheer Girgis Tawfiq (aged 45, husband, father of four, brother in law of George Erian, cousin of Sameh, barber, **beaten to death** by police after he made a complaint concerning threats made against him by a Muslim)

Sameh (cousin of Maheer Girgis Tawfiq, said “We headed to the morgue to see Maheer’s body and noticed some bruises on different parts of it – a blue bruise at the back of his neck, his lips turned blue, and we saw white foam coming out of his mouth. There was also blood in his pupils”)

George Erian (brother in law of Maheer Girgis Tawfiq, said A group of police officers threatened Maheer’s brothers that if they insisted that he was killed at the police station or demanded an autopsy, they would receive charges, meaning the police would fabricate charges against them...The perpetrator must be brought to a fair trial. I will not find consolation until the perpetrators are held accountable. We want to feel that we live under the rule of law, with justice and equality, and not in a state of repression within the walls of state institutions, and of bullying outside those walls”)

## India

Fr Cedric Prakash SJ (**UPDATE**: condemned the July 17, 2018 attack by Hindu radicals on 79 year old Hindu reformer Swami Agnivesh and the lynching of 32 year old computer technician Mohammed Azam: "The tragedy of lynchings in India today is that they apparently have the official sanction by the Government of the day: in fact, some of the central ministers, in the recent past, have publicly anointed those responsible for these bloody murders. All this portends ill for the future of the country")

Daniel Nadarkhani (teenaged son of Pastor Youcef Nadarkhani, attacked with an electroshock weapon by police when he answered the door during an early morning raid on his home)

## Nicaragua

Fr Augusto Gutierrez (said “We've gotten death threats because they say we're the ringleaders of this situation, but we have been out in public because what the government of Daniel Ortega is doing is unjust. This is a genocide because there's no other name for it. Don't let us die. Please, intervene, do something...for three months the government has lashed out against the population all over Nicaragua, including Monimbo, which has remained

steadfast with great courage. But now they're killing us...with heavy military weapons, they're desecrating churches and destroying lives”, in hiding)

Fr Raul Zamora (described how he opened his church as a refuge for demonstrating college students after they came under attack by government agents: "That university is actually under my pastoral care. It is right next to our parish. I am in charge of attending to those students spiritually. I knew the students personally. I told them, 'Come to the parish. Come to the parish. Don't stay there' ...If the cross is not in our life, if we are not willing to suffer for love, then our religion just stays as something that is exterior. Just trying to do what is ritually appropriate. Our faith starts when we have that deep conviction in Jesus and his message. This is what we learned")

## Pakistan

Shan Jalal (aged 17, witnessed four armed men shooting at his church while he was hanging posters on the outside walls, ran inside to warn the youth group that was meeting at the time, two of the men followed him and shot over the heads of the youths damaging windows and the altar, ripped Bibles and shouted "God is greater", later said "We are under severe threat from the local Muslim community and they are threatening us to kill us and to destroy our houses. Many of us have not gone to work today for fear of a reprisal attack, we stay awake all night to watch over and protect our houses")

Saleem Masih (aged 36, tackled one of the shooters after the two shooters had run out of ammunition, other youth group members helped and restrained the other and called police, police arrived 30 minutes later, a female relative later doused the church and female parishioners with gasoline but was also restrained and arrested)

Shahaan (activist, said of the national elections "Christians are extremely disappointed at this time because none of the Parties have nominated a single Christian candidate for even one seat reserved for minorities in the National Assembly. It is quite possible that their will be no representation of Christians or their concerns in the National Assembly...Because of this hard line rhetoric surrounding the blasphemy legislation [295C] Tareek-e-Insaf has gained support in the country leaving Christians insecure and doubtful about the protection of their rights should party leader Imran Khan form the government. A surprising factor contributing to this anxiety is the participation of hardcore Muslim extremist groups in the elections who are involved in Tehreek e Labaik...This is the party of Moulana Khadim Hussain Rizwi who praised Mumtaz Qadri the murderer of former governor Salman Taseer and a who also is an ardent support of 295C")

## Turkey

Pastor Andrew Brunson (U.S. citizen, husband of Norine Brunson, detained as a 'national security risk' on [October 7, 2016](#); confirmed to be a hostage at a [September 28, 2017](#) press conference by President Recep Tayyip Erdogan, the President explicitly called for the U.S. government to exchange him for Sufi cleric and U.S. resident Fethullah Gulen; **UPDATE:** a court ruled that he is to be released from jail and placed under house arrest; banned him from leaving the country)

Norine Brunson (**UPDATE:** acted to ensure her husband's transfer to house arrest)

Kristina Arriaga de Bucholz (United States Commission on International Religious Freedom [USCIRF] Vice Chairman, attorney; **UPDATE:** attended the hearing, stated "It is good that Pastor Brunson will have some relief after being held in a Turkish prison for more than 600 days. But it is not enough. The Turkish government has deprived this innocent man of his due process rights and liberty for too long, and it must completely release him")

## Uganda

**Event:** Three Christian children were abducted from [Kabuna villiage, near Budaka, Kaderuna district](#) on [December 9, 2015](#) by Muslims, **UPDATE:** **escaped, reunited with their family**

Madengho Badir (aged 45, convert from Islam, father of Nabukwasi Shakira, Gessa Amuza and Wagti Musitafa, children abducted; **UPDATE:** recovered his children after their escape, said “It seems the person who took my children had an intention of Islamizing them as well as wanting them to join a terrorist group. Thank God for saving my children in a miraculous way. Though the children looked miserable, sickly and confused, now with counseling they will be restored back. The God who saved them is able to restore them back to good, sound mind”)

Nabukwasi Shakira (aged 7, child of Madengho Badir, abducted; **UPDATE:** escaped)

Gessa Amuza (aged 10, child of Madengho Badir, abducted; **UPDATE:** escaped)

Wagti Musitafa (aged 12, child of Madengho Badir, abducted; **UPDATE:** escaped, said “Daily we were taught the Quran, and on some occasions we lacked food to eat. After two years, the man who was caring for us told us that he was planning to take us outside Uganda, and this made us fearful, such that after lunch while being all alone we managed to escape from that house without knowing where we were heading to”)
